## **President's Initiatives**

<u>Process</u> - a series of continuous developments; the process of growth.

"To continue and strengthen Peabody's administrative abilities, and impact its legacy," says, President Juanita Owens-Wyatt, "there must be dedication, harmony, concession, innovation and a consistent process of operation. Therefore, I submit the following proposal:"

1. Revise the Constitution regarding task and composition of Board of Directors, establish two positions: (a) Financial Secretary and (b) Sergeant-At-Arms, and change Membership Chairman to an elected position, Membership Secretary.

#### REVISE CONSTITUTION

#### Article V: OFFICERS

Section 1. The officers of the PHSNAA shall be President, Vice President, Secretary, Treasurer, Chaplain and Historian. Duties shall be as described in the By-Laws of the Association PROPOSED CHANGE

The officers of the PHSNAA shall be President, Vice President, Secretary, Financial Secretary, Treasurer, Membership Secretary, Chaplain, Historian, and Sergeant-At-Arms.

### Article VII: BOARD OF DIRECTORS - EXECUTIVE COMMITTEE

Section 1: There shall be a Board of Directors composed of the elected officers of the Association. The immediate past-president shall serve as an ex-officio member of the Board. <u>PROPOSED CHANGE</u>

There shall be a Board of Directors composed of twenty-four (24) members plus a Chairman (President); immediate past-president, and Registered Agent for the Association. The 1<sup>st</sup> term would include persons from even numbered graduating classes, and the 2<sup>nd</sup> term would include persons from odd numbered graduating classes.
